### President's Report

This has been another year of expansion for SAAA. We held events in 5 towns this year: Calgary, Edmonton, Red Deer, Fort MacMurray, and Medicine Hat. We've also been hosting more events, especially in-person ones since this has been our first year "post-pandemic".

We've also been experimenting, as a board, with different ways to schedule events. We had started with planning events on a quarterly basis alongside our board meetings but found that a dwindling events list was a bad look to newcomers. We are now trying to do more regular events such as a discussion night on the same evening every other month, as well as a monthly event planning system to keep a steady supply of new events. This will hopefully even out the load across the year instead of making board members plan a bunch of events several months out and help the members get more regular information while still knowing what to expect a month or two out.

A challenge for the board as SAAA expands is that we will likely not have board members in every community that we hold events. Up till now the events committee has been the board but a priority for me in the upcoming year is to create an events committee that can handle planning and scheduling on an ongoing basis.

We are also continuing our shift more from a social organization to an advocacy group. This has included more discussion nights to talk about issues affecting our community, public talks to educate the broader community, attending pride events, and producing educational resources like our new brochure (Thanks to Jad and Danica for that).

To better inform our advocacy we are preparing 2 surveys, this is being led by Bailey. One of our membership to learn about demographics, the community's needs, events and recources that would be popular, and how best to communicate with the membership. The second survey will be targeted for a-specs across Canada and will be focused on social, housing, employment, and medical discrimination, as well as demographics. We want to do this because while there is some research on these topics there isn't much on Canadians and it is often difficult to transfer queer statistics from the US and UK where the bulk of this research (in English) is from. This data will inform our advocacy priorities but it will also allow us to talk with authority on these topics since we can present statistics and testimony.

We're also fundraising to do all of this. We're are supported by you, the community. This can include cash donations but we are also considering merch, particularly keychains and lanyards since the pin/button market is over-saturated. We've already talked to some artists in our community and commercial producers.
